Quarterly Provider Newsletter: Arts Commission Announces Program with FSSA to Bring Arts and Creativity to Older Adults | Best Practice - Medicaid Effective Date | 1135 Waiver Change

The Indiana Arts Commission (IAC) recently announced a new partnership with Indiana Family and Social Services Administration (FSSA) Division of Aging geared towards benefiting older adults in Indiana.

Lifelong Arts Indiana is a learning opportunity for aging services providers and artists to develop their skills in providing creative experiences for older adults. The program equips participants with the necessary knowledge and skills to provide impactful creative experiences for older adults, ages sixty-five and older, in their community-- and provides access to the funds to help make it happen.

"Through national research and previous agency work in this area, we have seen the immense impact that creative activity has on Indiana's older adults," said Miah Michaelsen, IAC Executive Director. "We are incredibly grateful for the partnership of the FSSA to bring training and funding to support this work around the state."

Lifelong Arts Indiana has two tracks, one for teaching artists and the other for aging services providers.

Teaching artists can apply to be a part of the Lifelong Arts Indiana Artist Cohort. Selected participants complete a virtual, three-day workshop led by Lifetime Arts, a national leader in creative aging program development. Training will explore best practices in creative aging and strategies to develop an effective, sequential arts learning experience for older adults. Following training, participants will receive personal coaching and up to \$1,500 via an Early Action Grant opportunity. The deadline to apply for the artist cohort is March 30, 2023.

Apply to be a part of the artist cohort.

Aging services providers can sign up for one of four free, in-person workshops. The training sessions are as follows:

- April 28, 2023: Fort Wayne
- June 23, 2023: Bloomington
- Sept. 19, 2023: Evansville
- Nov. 14, 2023: Gary

Sign up to attend a training for aging services providers.

The trainings are designed for professionals in the aging services community, such as area agencies on aging, senior centers, or other community-based senior serving organizations, and will focus on information about creative aging theory, step-by-step planning support, practical application of the learnings, and the opportunity for grant support.

Aging services provider training participants will be eligible to apply for an Early Action Grant to fund a sequential arts-learning experience for a group of older adults in their community. Grants will be for up



to \$5,000 and must be led by a qualified artist.

If there is a Medicaid effective date available, always be sure to include it when entering information for an individual's PASRR referral.

REMINDER: Section 1135 Waiver to Change on May 11

A recent announcement from DHHS was issued regarding the official May 11, 2023 end of the public health emergency (PHE). With this change, the 30-day delay of PASRR Level I screenings and Level II evaluations will also terminate on May 11, 2023.

Note that this planned date is beyond the 60-day notice that CMS has previously said would be given to allow states to unwind any COVID-related changes to their PASRR program. As such, CMS will expect all states to resume full pre-admission PASRR activities as of May 12, 2023.

PROCESS UPDATE: DOA Waiver is No Longer a Substitute for the LOC

Please be aware that going forward, an uploaded waiver will no longer stand as substitute for Level of Care (LOC). A short form LOC is needed in addition to the attachment of the Division of Aging waiver. This excludes BDDS community waivers for MFP/CIH.

BEST PRACTICES: Assessment Tips & Reminders

1. To help with timely completion of Level II assessments, please **fax in all documentation requested by Assessors**. This helps the Level II Clinicians complete your summary of findings and reudces turnround times. Some items an Assessor may ask for include:

PT/OT notes Medication Administration Records (MAR) Psychiatric notes or evaluations

Keep in mind that **documentation must be faxed directly to Maximus from the facility**, and cannot be sent via email or taken offsite by an Assessor. Likewise, any mental health diagnosis used in a Level II must come from a document signed by a Medical Doctor or Nurse practitioner, and must have been completed within the past year (i.e. psychiatric evaluation or progress note, H&P or medical progress note)

- 2. Remember that **submitters are always expected to respond to contact attempts** to schedule Level II assessments and participate in the interview. If the submitter of the Level I/Level of Care is not the person Maximus should contact to schedule and participate in the Level II, then the appropriate contact's information should be noted in the Level I communication box or notes section. If we cannot reach the facility or hospital to schedule the assessment, the assessment may be cancelled, and the submitter will have to resubmit.
- 3. Be sure to **check your email for the digital Scheduling Attestation and Release of Information forms** submitted by Assessors for signature. This form is used to confirm that the Assessor completed the interview at the facility and to ensure a Release of Information is signed, where applicable.

Important Process Reminder: Level of Care Added to PathTracker Admission Modal

Keep in mind that nursing facility users now must **select the appropriate Level Of Care (LOC Short or Long) assessment** on the PathTracker Admission modal when admitting Medicaid recipients to their respective nursing facilities.

The Level Of Care (LOC Short or Long) assessment selected should correspond to the timeframe matching the individual's initial length of stay for the particular admission in question (see screenshots below):

BEST PRACTICES: Assessment Tips & Reminders

1. A new PASRR or Level of Care is not required if there is a current one, if there has not been a status change, and if the individual is returning to a nursing facility.

2. Keep in mind that a Level of Care is required for Medicaid, when Medicaid is pending, and whenever a Level II is required.
